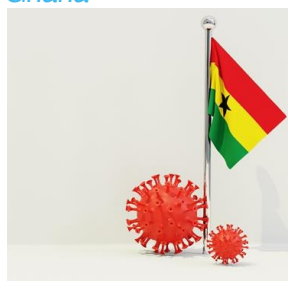
KEY TRENDS

Here is a snapshot of the key trends that we're seeing in the resources collected.

- Majority of articles collected this month refer to the private sector delivery of **vaccines** (27%), **digital health innovations** (24%) and the private sector's role in the **general response** to COVID-19 (18%).
- As we navigate the recovery phase of the pandemic, fewer articles are focusing on the role of the private sector in the delivery of **diagnostics** (14%) and **PPE** (11%).
- **Service delivery** (56%) and **governance** (17%) continue to be the leading topics of discussion for the articles collected in this month.
